

**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
SOUTHERN PUBLIC RELATIONS FEDERATION, INC..**

Pursuant to the provisions of Section 10-3A-80 of the code of Alabama, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.:

FIRST: Article III is hereby amended to delete Section 2 in its entirety and thereby substitute it with a new Section 2 and to also add a Section 3, all with the following;

ARTICLE III – PURPOSES

Section 2. The corporate is organized exclusively for charitable, scientific and educational purposes within the meaning of §501(c)(6) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue law (the "Code"):

Section 3. The corporation shall have all the general powers as enumerated in § 10-3A-1, et seq., Ala. Code, 1975.

SECOND: Article VI, Section 2, is hereby deleted in its entirety and substituted with the following;


ARTICLE VI – CORPORATE PROPERTY

Section 2. No part of the income or receipts of this Corporation shall ever inure to the benefits of or be distributed to any individual, member or members of this Corporation, except that the Corporation shall be authorized and empowered to pay reasonable compensation for service rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of settlements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of the articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501(c)(6) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a Corporation, contributions to which are deductible

under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

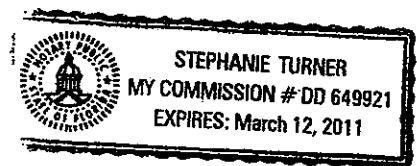


